



2024 School Fees

1. Application Fee

A non-refundable application fee of \$350 is charged for each application for enrolment. This covers the administration cost associated with enrolment.

2. Enrolment Fee

A non-refundable Enrolment Fee of \$3,500 must accompany the acceptance of an Offer of Confirmed Enrolment. The Application fee and Enrolment Fee are non-refundable and not credited towards Fees.

3. Annual Fees (Per Student)

*Boarding fees include GST on the food component.

** Other Fees will be charged to the family fee account in Term 1 or on enrolment. If you are a new student or on a payment plan this will be included in your first payment of the year.

- Digital Texts – annual charge for Year 7 to Year 12 for use of digital resources.
- ICT Resource Fee – annual charge for costs associated with provision of electronic devices, software, and IT support services.
- Holistic Immersions Program covers:
 - Year 5, Year 6, Year 7, Year 10 - Overnight school camps.
 - Year 8 - Songlines Program 5-day experience in the Sydney basin.
 - Year 9 - Far North QLD 13-day immersion experience.
 - Year 11 - Overnight school retreat.

A Capital Levy of \$600 per annum is charged to each family account to support the ongoing improvements to our existing buildings. This charge is applied to the family fee account in Term 1 or on enrolment. If you are on a payment plan this will be included in your first payment of the year.

4. Fees in Advance

A discount is available on Tuition and Boarding Fees if these annual fees are paid in advance.

- For existing students, payment of the annual fees by the close of business on Friday, 5 January 2024 will receive a discount of 2.5%. Payment of fees for more than one year (future years) will receive a discount of 2.5% on the future fees after factoring the annual fee increase on each subsequent year.
- For new students, Payment of the annual fees by the close of business on Friday, 15 December 2023 will receive discount of 2.5%. Payment of the fees for more than one year (future years) will receive a discount of 2.5% on the future fees after factoring the annual fee increase on each subsequent year.

5. Payment Methods

The preferred method of payment for school fees is monthly direct debit (over 10 months) and families are encouraged to utilise the payment plan option.

10 Monthly by Direct Debit

The Monthly Payment Plan allows you to pay charges for Tuition and Other Fees, Boarding (if applicable) in 10 instalments each year, from January to October, on the 15th or 25th of the month. Sundry charges for extra-curricular activities and any incidentals will also be included in the Payment Plan. These



additional charges will be charged to your fee account as incurred and your full statement balance will be deducted on the 15th or 25th of each month. Your Fee Statement will be emailed to you in the first week of the month due.

The monthly plan option is not available on Term 1 fees for those students entering Loreto Normanhurst in 2024 and fees are due as stated on the invoice. If your direct debit fails on the date payment is due then it will be reprocessed 3 days after the due date and a reprocessing fee of \$15 will be applied to your school fee account.

7. Instalment Plans

¹ Monthly payment for students new to Loreto Normanhurst in 2024 is April through to October (paying over 7 months), with Term 1 fees paid in advance in November/December in the year prior to entry.

² Monthly payment for current students is January through to October (paying over 10 months).

8. Extra Subjects

Music tuition is offered in a wide range of musical instruments and singing. Tuition is also offered in Speech & Drama, Tennis and Swimming. Application for these extra subjects is distributed during Term 2 and Term 4. The fees are charged half yearly in Term 1 (for Semester 1) and Term 3 (for Semester 2). New students will be given the information prior to starting at Loreto Normanhurst. If a student wishes to discontinue four weeks' notice in writing is required.

Sport registrations, overnight camps, retreats and some excursions along with fees for extra subjects may be subject to a 10% Goods and Services Tax (GST).

9. Sibling Discounts

Discounts on tuition fees are available for the second child in a family (10%), the third child (20%), and the fourth and subsequent children (30%) provided that the children are attending the School simultaneously.

10. Building Fund Donations

Any voluntary donations in support of the Loreto Normanhurst Building Fund are gratefully received. These donations are tax-deductible and used to fund the ongoing improvements to our future and existing capital programs. Receipts are provided after the end of the financial year.



11. Administration Charge for Late Payment

If School fees and additional sundry charges are not paid 21 days after the due date, a late payment administration fee of \$200 will apply to outstanding fees.

12. Withdrawal of a Student

If parents wish to withdraw a Day Student from the School, advance notice of not less than one (1) full term must be given. If parents wish to withdraw a Boarding Student from the School, advance notice of not less than two (2) full terms must be given.

If the required notice of withdrawal of a Student is not given, the parent must pay any remaining fees for the current term in addition to fees for the following School term plus GST in lieu of notice for a Day Student, or two (2) full School terms' fees plus GST for a Boarding Student.

13. Cases of Hardship

Parents who encounter difficulties in paying fees, on account of unexpected hardship, are invited to discuss the matter with the Principal.

14. Fee Collection Policy

This Policy outlines the terms of payment and process in regard to collection of fees outstanding.
